

# **Campus Reopening Guidelines**

We, at La Jolla Montessori School, have been planning for and preparing (and practicing) on how to reopen in a way that prioritizes the health and safety of our entire school community. The purpose of this document is to outline the protocols and procedures that have been implemented to achieve that. As you know, LJMS has been open since May 18<sup>th</sup>, so, many of the protocols you will read about have been in practice for months.

LJMS's teachers and administration are very much looking forward to welcoming students back to campus. One significant point to keep in mind for families is that while we believe the risk is manageable and the socio-affective benefits for students will be substantial, it would be impossible and impractical to state that there is no risk at all.

Our staff will use their professionalism to create classroom environments which - to the best of their ability and within the limitations that exist - promote maximum safety as outlined in this document. As such, we ask each family to read through what is outlined here very carefully and be sure your family understands and considers the limitations that exist.

## **Key Information**

As per the Centers for Disease Control, the key factors in minimizing the risk of infection and community spread of Covid-19 are:

- Minimize the chance of exposure
- Promote the use of everyday preventive actions
- Protect high-risk populations

LJMS's approach to minimizing risk is detailed below. We appreciate the understanding of all LJMS parents that protocols may evolve as we refine and analyze our practices on an ongoing basis.

## **Updates for Members of the LJMS Community**

#### **Student and Staff Attendance**

Students and faculty members who show any signs of illness may not attend school and will be asked to show proof of a negative Covid test before they return to school (or they can get a doctor's note or stay home for 14 days) and it will have to be 72 hours after the symptoms have gone.

Examples of symptoms include:

- a persistent cough
- a temperature > 100°F
- chills
- muscle pain
- shortness of breath or difficulty breathing

- congestion or runny nose
- temporary loss of taste or smell
- nausea
- vomiting
- diarrhea
- fatigue

sore throat

If any member of the household exhibits any of the above symptoms, please refrain from coming to campus until you have been symptom-free for at least 72 hours. If a student or staff member has had contact with a confirmed Covid-19 case, they must quarantine at home for 14 days, even with a negative test.

#### **After International Travel**

Students and staff returning from any international travel will need to self-isolate for 14-days, commencing the day <u>after</u> arrival in San Diego. For instance, someone returning from abroad on September 1<sup>st</sup> would be free to return to school on September 16<sup>th</sup>.

Also, if any LJMS community member hosts or socializes with a visitor or other contact who has travelled internationally, we require all members of that household to self-quarantine away from the LJMS campus for 14 days. We also require that you disclose to the office your intention to self-quarantine due to contact with someone who has travelled internationally.



## **Returning to the LJMS Facility**

#### **Arrival Procedure**

We request that parents take their child's temperature before leaving home each morning. Should a child's temperature be 100°F or higher, please refrain from bringing them to school and notify the office.

The following steps are our arrival procedure:

- 1. Temperature check
  - a. A staff member will take your child's temperature using a non-touch thermometer (temperatures will again be taken in the middle of the day)
- 2. Symptom Check
  - a. The staff member will ask you if anyone in your family has had an illness or exposure to a positive case of COVID-19. If yes is answered to any of the questions, the child will not be allowed to attend school.
- 3. Wellness Check
  - a. The staff member will check that your child is symptom-free before allowing them inside. We will ask that your child pull down their mask so we can see their nose.
- 4. Sign In/Out
  - a. Staff will be signing your child in and out to help minimize exposure.
- 5. Handwashing
  - a. Children will enter the classroom and go straight to the sink to wash their hands

We ask parents who accompany their children to school to remain with them until they are cleared following the wellness check.

Should a student's temperature be higher than 100°F on the first check, we will send the child and parent to the office to use the ear thermometer to check again. Should a student's temperature remain higher than 100°F for the second check, we will ask the child to return home for 72 hours after the fever has broken (and a negative Covid test result).

If we see a child with any of the above symptoms during our wellness check, we will ask the child to return home for 72 hours after the symptoms have passed. If a staff member or child has a runny nose due to allergies, we will need to have a Doctor's note stating that fact.

We ask that all parents wear a face mask for drop-off and pick-up.

Drop off times are as follows:

8:15-8:30 - Primary Classes (Sea Turtles & Starfish)

8:30-8:45 - Toddler classes (Dolphins & Jellyfish)

#### **Departure Procedure**

We ask that all parents wear a face mask for drop-off and pick-up. Please remember to stay 6 feet away from other parents and staff. Here are the locations for pick up based on your child's classroom:



Pick up times are as follows:

2:30-2:45 - Primary Classes (Sea Turtles & Starfish)

2:45-3:00 - Toddler Classes (Dolphins & Jellyfish)

#### **Parents on Campus**

If you need to speak to someone in the office, we prefer and recommend a phone/zoom call or email. If you must come in person, please stay outside of the office door until invited in.

#### Staff

All staff must wash hands and complete a daily temperature and wellness check before accepting children.

In addition, staff must arrive on campus wearing a face mask. Spare disposable masks will be available on-site if required.

Hand sanitizers will be located in each classroom and in each shared space i.e., kitchen, office area, etc. Please make sure to utilize hand sanitizers whenever hand washing is not feasible.

## **Updated Actions for LJMS Students, Staff and Parents**

#### **Physical Distancing and Movement on Campus**

Classrooms and outside areas will be modified to encourage age-appropriate social distancing.

Physical contact and close physical proximity between and amongst all members of the LJMS community will be limited. As such, the practice of shaking hands when students and teachers greet each other will not be continued until such time that it is safe to return to such a way of interacting socially. Teachers will still give lessons to the students in their classroom and, as such, will be closer than 6 feet during these times.

As we have such a generous outdoor space, we will be utilizing our outdoor environment to its fullest extent. After adding more shading, we have divided the playground and courtyard up in such a way that every primary classroom can send children outside, with an additional staff member, without interacting with other classrooms. This allows for a limited number of 16 children inside the classroom at a time, with the remaining children outside. Children will rotate inside and outside, so everyone works inside and plays outside throughout the work period. The playground will also be on a rotation, so children don't mix from different classrooms. The playground structure will be cleaned between each classroom's use.

Additionally, in the toddler community, we will limit the number of children inside at a time to 12 per classroom. The remaining children will be utilizing our outdoor patio space to work and play with an additional staff member. Children will rotate inside and outside, so everyone works inside and outside throughout the work period.

Nap beds will be spaced 6 feet apart or 3 feet apart with a head to toe orientation. Bedding will be washed or sent home weekly. Bedding should be clean when returned to school every Monday.



#### **Mixing Classrooms**

To keep children within their own "cohort," we will not mix children on the playground or for after school care. Some children may be able to stay after school within their classroom with a staff member staying beyond 3pm.

Also, to prevent mixing between classrooms: if a student has a sibling within the same age range, we will keep siblings together for the time being. We will not combine a toddler into a primary classroom. We will only combine siblings within the same age range.

#### **Partitions**

Every table that is shared by two or more children will have a clear partition between the children. In this way, our students get more distance while still speaking or working socially together.

#### Masks

Face masks will be mandatory for all staff members. We require that all children ages two and up bring a mask to school (1 should be left on site as back up). We will encourage the children to wear masks throughout the day to the best of their ability. When outside, both the use of face masks and students' physical activity will be carefully monitored by teachers to minimize the risk of students overheating. We will keep children in the shade and will remove masks if needed when outside.

#### Handwashing

Handwashing will occur at the following times:

- Upon arrival at school
- Every 45 minutes
- After sneezing or blowing your nose
- Before and after eating
- After the use of cleaning products (staff only)
- After using the toilet

Where possible, a teacher will turn the tap on and off for younger students using a paper towel to minimize the risk of many students touching the same tap with unclean hands. Older students will be asked to use a paper towel when turning the tap on and off themselves. The bathrooms will be cleaned several times throughout the day and after every use by a toddler student.

Please refer to Appendix A: <u>Handwashing Procedure</u>.

#### **Food and Drink**

We will not have communal, "family style" meals at school during this time. We ask that you pack your child's lunch and morning & afternoon snacks in separate containers. Also, please include all cutlery needed for their meal. Children will eat at their table, and pack their Tupperware and cutlery back into their lunchbox after eating.



Please provide a water bottle, labeled clearly with your child's name, and filled with only water for your child to take to school. Students will keep water bottles on their tables or in their cubbies and will be asked not to touch other students' personal items.

More drinking water is available for students, and refills will be managed by a teacher who will ensure that there is no contact between the student's water bottle and the drinking water dispenser.

We ask that parents wash their child's water bottle thoroughly in warm, soapy water at the end of each day. We also ask that lunchboxes are kept clean (most can be washed in a washing machine and set to air dry).

#### **Bathroom Protocol at School**

Staff will attend to toddlers in the bathroom and wipe down toilets, sink, and handles after each use. Primary students will be able to use the bathroom on their own, individually, and the staff will clean the bathroom 3-4 times per day.

#### **Illness at School**

Students who show signs of illness as outlined in the Student and Staff Attendance section above, have a temperature higher than 100°F, a persistent cough, or a runny nose will be sent home from school. A member of the administration or a teacher will phone a parent to arrange immediate pick-up from the office. We will recommend a COVID-19 test, but either way, the child will need to remain at home until 72 hours after the symptoms have passed.

Teachers are asked to inform the office if a child registers a temperature higher than 100°F during the day.

### **Updated Measures for the LJMS Facility**

#### **Classrooms**

To improve ventilation, all windows and sliding doors will be open and air conditioning on for the duration of the school day.

Children will work at individual tables or tables with partitions. If a child moves outside and someone else uses that table, it will be disinfected first. Rugs will be available for floor work and will be cleaned regularly.

Toddler & Primary materials will be cleaned after every use. Materials will be disinfected by a teacher at the end of each day.

In addition, the classrooms are fogged with a disinfectant daily and cleaned by janitorial staff every day.

Primary students will be asked to bring their own equipment to school to be kept in a pencil case marked clearly with their names. Required items include:

- Toddler: TBD
- Primary: pencil, eraser, sharpener, scissors, coloring pencils



#### **Cleaning Schedule and Routine**

A cleaning routine is scheduled after each day and periodically throughout the day. When cleaning, we disinfect the following high-touch objects.

- Doorknobs and handles
- Light switches
- Tables and counters
- Toilet door handles
- Toilet flush handles

- Hand sanitizer pumps
- Faucets
- Chairs
- Cabinets
- Playground structure cleaned between every classroom use

All classrooms will be equipped with a kit for cleaning products. Primary Students will be permitted to clean their own work area with a soap/detergent solution that is dispensed by the teacher. Surfaces will be *cleaned* before they are *disinfected*. Children will <u>not</u> come into contact with disinfectant spray.

- Avoid indoor public spaces, to the best of our ability.
- Limit playdates to the best of our ability, to avoid cross-contamination between schools and classrooms.
- Maintain transparency and honesty about our, and anyone in our household's, exposure to COVID-19.


# Coughing manners'
